1. Call to Order by Mayor Nelson @ 5:30pm.
2. Roll Call by Sandra Herring.
3. Certify Posting in accordance with State Law.
4. Invocation & Pledge by Billie Jean Scaggs and Elizabeth Nelson.
5. Budget discussion for FY 2012/2013 amendment and discussion of proposed budget for FY 2013/2014.

Discussion began by City Manager indicating that this has been a difficult budget year with the unexpected decline in citation revenue, the uncollected emergency services fees has really taken a cut of our fiscal year budget. In addition, we had the water plant incident at a cost of \$275,000 in repairs and another \$250,000 in personnel charges for the insurance claim. Discussion continued with projects desired by the Council such as road repairs, drainage work, mowing contract, hire a public works director,

Mr. McDonald indicated that the new budget does not include a tax increase nor does it include any water rate increases. He also indicated that the new budget would reflect some merit raises, proposed demand raises and 3% raises for the remaining employees, financing a new fire truck, financing 3 new police vehicles and increased cost on health care benefits.

Council indicated that in order for them to move forward with a new budget that we must find a way to balance the amended budget and then prepare a new budget without any extras included to really see what the needs are as far as increases to taxes or water rates are concerned.

Mr. McDonald indicated that he would have those prepared for tomorrows meeting.

Councilmember Tate made motion to adjourn.

Mayor Pro-Tem Henderson seconded this motion and the motion carried as follows:


