Interim City Manager Dick Fletcher started the discussion by indicating to Council that it was going to be a year to make some really hard decisions. Open the meeting with discussion on the taxes. Marlin's current tax rate is .675 per one hundred dollar value. Due to the fact that the city has a 1/5 cent property tax reduction, the City must go with the roll back calculations. The roll back rate is .671 which is less than the current rate and will bring less revenue to a budget that is already carrying a negative balance. Even to stay with the current rate, the city could be looking at a roll back election. With the current needs of the City and the Councils desire to continue to fund a paid fire department, a tax increase is inevitable. The Council must decide how much of an increase is needed to fill the needs of the departments. Each cent equates to \$11,477.10 to the general fund. With a deficit of \$288,000 that would be a .26 cent increase and Mr. Fletcher is not recommending that but will support whatever Council desires. If an increase of .26 cents is advertised then the city can always decrease that amount but cannot go over that amount. The other issue is the debt service rate. There has not been an increase to the debt service rate in quite some time. The debt is for the water plant, water lines, sewer projects, etc. and the current debt service rate of \$2.10 per thousand gallons is not enough to management those payments. With an increase of \$1.00 per thousand gallons, that would carry the majority of the debt with a smaller amount coming from the water fund and would be a tolerable amount for the customers. There was additional discussion on the police cars and additional personnel but that the Council needed to direct the City Manager on how to proceed with the public hearings for the tax rate

and the budget. Council had brief discussion on how to move forward. By advertising a tax increase of .26 cents then the Council could adopt a lower rate after the public hearings depending on public input. Council agreed on the advertisement of the .26 cents increase.
