

ORDINANCE No. 15-013

AN ORDINANCE DECLARING THE RESULTS OF A GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF MARLIN, TEXAS ON THE 9<sup>TH</sup> DAY OF MAY 2015, FOR THE ELECTION OF COUNCILMEMBER PRECINCT 3 AND COUNCILMEMBER PRECINCT 1 UNOPPOSED; AND DECLARING AN EMERGENCY.

WHEREAS, on the 12<sup>th</sup> day of May 2015, the City Council of the City of Marlin, Texas, at a Regular Scheduled Council Meeting, canvassed the returns of the General Municipal Election held on the 9<sup>th</sup> day of May 2015 for the election of one Councilmember for Precinct 3, appearing as a result of such canvass that the following named persons received the following numbers of votes for:

And further appearing from such canvass that Billie Jean Scaggs received the highest number of votes cast for Councilmember Precinct 3.

WHEREAS, the City Secretary has certified that no names were to be placed on a list of write-in candidates for the ballot and there were no propositions to appear on the ballot in said election;

WHEREAS, the City Secretary has certified that the following candidate for Councilmember Precinct 1 was unopposed for election to the office to be on the ballot in the May 9<sup>th</sup>, 2015 General Municipal Election:

Norman D. Erskine – Unopposed for Election to the Office of Councilmember Precinct 1.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and City Council of the City of Marlin, Texas:

Part 1: That candidate for Councilmember Precinct 1 position, Norman D. Erskine, and candidate for Councilmember Precinct 3 position, Billie Jean Scaggs are declared the duly elected Councilmembers for Precinct 1 and Precinct 3 respectively to serve a two (2) year term of office.

Part 2: That all Norman D. Erskine and Billie Jean Scaggs shall be sworn into office as required by law.

Part 3: That this Ordinance shall take effect immediately upon adoption and declare an emergency.
