The non-taxable option would have had to occur within 60 days of the incurring of the expense. Mr. Gilley prepared and advertised for bids on the notes and they received one bid from BB&T. The request was for \$545,000 plus interest and closing. It is offered as a 7 year note at 2.6330% calculated TIC.

After brief discussion, Councilmember Porter made motion to approve the issuance and sale of "City of Marlin, Texas, Tax Notes, Taxable Series 2016 to BB&T at the rates described.
