Frank Steele from Anderson, Marx and Bohls of Corsicana presented the Council with the FY 14/15 Audit. Mr. Steele indicated that FY 14/15 Marlin had the most favorable audit to date. It shows that the City Council made some hard choices by increasing the tax rate and water rates is helping the city pull out of the super recession of 2008. The report is favorable "non-qualified" which is the highest rating that can be issued. He indicated years ago that Marlin had received the only "disclaimer" rating they have ever put forth. It is clear that hard work and consistency has played a large role in that process. The general fund began the FY with a balance of \$366,539 and ended with a balance of \$311,081, an increase of \$55,458. The water fund began the FY with a balance of \$289,944 and ended with a balance of \$241,491, a decrease of \$48,453.
