City Health coverage was put out to market and most declined to bid due to three large claims pending increasing our claims rate by 42%. Current is \$281.48 employee only rate, proposed new rate is \$365.55 employee only rate. There are several Firstcare Plan options ranging from a higher deductible such as \$3,000, \$4,000 or \$5,000 or moving to a plan of greater employee out of packet such as a 75/25 or 60/40. Council discussed staying with the current plan.
