Bid Requirements for ALL bidders:

This bid is for one year with an option for four (4) additional one (1) year extensions as mutually agreed and proposed schedule of contract.

- Proof of current general liability insurance
- Price for scope of work per year
- Price for extra mowing
- Five (5) References of Current Clients
- General information of company

Scope of work for ALL Bidders:

Services shall consist of twenty (20) mowing's and seven (7) Shredding's over the course of one (1) year. Last mowing or shredding at start of winter season after the first heavy frost.

Contractor shall furnish the necessary labor, equipment, materials, personal safety equipment clothing, and liability insurance, to provide the following:

- All park entrances (inside/outside) shall be mowed and weed-eat.
- All turf areas shall be mowed.
- Weed eat fringes left by mowers around building, post, tombstones, playground equipment, ornamental objects, picnic tables, trees or any other raised objects same day as mowing at each site. Blow off fringes and collect off parking lots.
- Edge all walks, curbs and driveways.
- Clippings shall be mulched to prevent smothering of the grass or an unsightly build-up.
- Debris will not be blown, raked or otherwise left in gutters or placed in storm drains.
- Trash shall be removed prior to mowing.
- Collect dead fall in all areas and place by road.
- Weed-eat inside of plot fences at cemeteries.
- Hand pull weeds at Dingrando Park.
- Chemically edge along chain link fences.
- Cut and chemically kill (Graze-On or equivalent) trees and mesquite along fence lines (No Chemicals Adjacent to Tombstones)

Billing Requirements for accepted proposal:

- Billing will be done on a monthly basis. (e-mailed acceptable)
- Photo documentation of work performed required. (e-mailed acceptable)
- Monthly bill will be 1/12 of the annual bid as awarded.

- Contract contingent upon continued appropriations of funds for this purpose, which appropriations shall not be unreasonably withheld.
