

**ORDINANCE No. 17-008**

**AN ORDINANCE DECLARING THE RESULTS OF A GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF MARLIN, TEXAS ON THE 6<sup>TH</sup> DAY OF MAY 2017, FOR THE ELECTION OF ONE (1) MAYOR-AT-LARGE, ONE (1) COUNCILMEMBER PRECINCT 1, ONE (1) COUNCILMEMBER PRECINCT 3, ONE (1) UNOPPOSED CANDIDATE FOR PRECINCT 5; AND DECLARING AN EMERGENCY.**

**WHEREAS**, on the 9<sup>th</sup> day of May 2017, the City Council of the City of Marlin, Texas, at a Regular Scheduled Council Meeting, canvassed the returns of the General Municipal Election held on the 6<sup>th</sup> day of May 2017 for the election of one Mayor-at-large, one Councilmember for Precinct 1 and one Councilmember for Precinct 3 and appearing as a result of such canvass that the following named persons received the following numbers of votes for:

**WHEREAS**, the City Secretary has certified that no names were to be placed on a list of write-in candidates for the ballot; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and City Council of the City of Marlin, Texas:

- Part 1: That Mayor-At-Large John Keefler,  
Councilmember Precinct 1 Susan Byrd,  
Councilmember Precinct 3 Terence McDavid,  
Councilmember Precinct 5 Curtis T. Smith Jr., are declared the duly elected Mayor and  
Councilmember to serve a two (2) year term of office that expires with the May 2019 Election.
- Part 2: That all of those above named as Mayor and Councilmembers shall be sworn into office in the  
same manner provided for candidates elected at the election.
- Part 3: That this Ordinance shall take effect immediately upon adoption and declare an emergency.
