Upon written request of the city staff and cost of services agreed up on by both parties (Aqua- Claire Tech. LLC "ACT" & the city of Marlin) act will perform the following maintenance tasks:

1. Provide training to the staff as needed with the 1st session to include classroom & field training starting in June 2013.
2. Equipment maintenance: As of this date, I anticipate a monthly visit to the Water Treatment Plant to assess maintenance conditions and make repairs as required or recommend staff or vendors to make repairs.
3. Provide quarterly reports to the city concerning the Water Treatment Plant operation.
4. Coordinate with the city engineer to ensure proper operation of the Water Treatment Plant.

Note: ACT is an original Equipment Manufacturer (OEM) and not an Engineering firm. Therefore, all coordination with state & federal agencies must be the responsibility of others.


5. Warranty: ACT responsibility is limited to new components purchased on behalf of the City of Marlin and installed by ACT. New components warranties are as provided by the components manufacturer, no other warranties apply.
6. This agreement can be cancelled by ACT or the City of Marlin upon thirty(30) days written Notice.
7. Rates shall be as outlined in Attachment "A".

NOTE: City Council agrees to fill 1 full time position and 1 part time position at the Water Plant.
